Your offer on this course is made in reliance upon and subject to the information provided by you in your student application for a place to study at UAL.

#### **Tuition Fees**

The tuition fees for Graduate Diploma Interior Design in your first academic year 2022/23 are payable in advance and are £ 23,610.00. Please see our tuition fee pages for further information.

You have been offered a place as an Overseas fee paying student. Please see the information at the end of this email for more information on fee status.

If you have applied (or decide to apply) to defer the start date of your course to the next academic year, please be aware that the tuition fees may be increased in accordance with UAL's Fees Policy. Similarly, you may have to pay a higher tuition fee in subsequent academic years, because fees are subject to change. Our Fees Policy also explains how your tuition fees may change over the course of your studies.

Please remember that the fees quoted above are for your tuition on the course only and do not include any other costs, such as living and travel expenses, and any field trips organised as part of your course or optional materials costs.

## **Additional Funding**

As a UAL offer holder, you may be eligible for additional funding. We strongly encourage you to look at what sources of additional funding are available, including student loans, bursaries or scholarships, depending on your level of study and fee status. ## **Progression Discount**

Postgraduate students starting in 2022/23 who have successfully completed an undergraduate level, PgDip/PgCert or Study Abroad programme at University of the Arts London are eligible for a Progression Discount equal to 20% of the total tuition fee for a taught Masters course. If you are eligible for the Progression Discount, the tuition fee in this offer letter will already have been adjusted to take this into account.

## Deposit to confirm your place

If you decide to accept this offer, you will be required to make a deposit as a condition of your Student Contract. Upon acceptance of this offer you will receive an email telling you how you can make your deposit. We encourage you to do this as soon as possible in order to confirm and secure your place on the course. The deposit you will be required to pay is £4000.00.

Making your deposit as early as possible will also help to ensure a smooth process once it is time to apply for your student route visa. When your deposit has been received and you have met all the remaining conditions of your offer, you will be eligible for a Confirmation of Acceptance for Studies (CAS) number, which you will need for your visa application.

CAS numbers will normally be emailed to eligible students from three months before the start date. Making your deposit in advance will therefore help you get you one step ahead in the visa application process by removing potential delays caused by the late delivery of your deposit.

When you enrol on your course, your deposit will form part of your total tuition fee payment. If you defer your place your deposit will be carried over to reserve your place on the course in the following academic year and will form part of your total tuition fee payment for that year. Please see 'Deferring your place' below for further information

If you join a course other than the one for which you originally accepted your place, the University will allow you to put your deposit towards the fees for that course. This does not apply to short courses or English language courses.

If you deferred your place in 2021/22, your deposit will be used as part of your tuition fees when you join the course in 2022/23.

You may change your mind and cancel your place on the course from the time you accept this offer until 14 days after the start date of your course at UAL. Please refer to the section titled 'Your Rights of Cancellation' for an explanation of the process and refunds payable on cancellation. If you want to terminate your Student Contract after this date, please refer to your Student Contract and the Fees Policy for details about what refund rights might

be applied.

If you are being sponsored by an official financial sponsor (as defined by the UK Home Office) you may request a deposit waiver. You should upload evidence of the sponsorship via your UAL Portal.

#### **Fee Status information**

You have been assessed as an Overseas student for fees purposes, as defined in the Education (Fees and Awards) Regulations 2007. Students who are unable to satisfy the residence and immigration criteria to be assessed as 'Home' have to be assessed as 'Overseas', and are liable for the higher rate of fees. Further information about these rules can be obtained from the UK Council for International Student Affairs (UKCISA).

By accepting our offer of admission, applicants are accepting the University's decision in relation to their fee status and shall be liable to pay fees at the rate notified. This decision is made on the basis of the available information or evidence that you provided at the time. Once students have enrolled with the University, decisions on fee status can only be changed in respect of subsequent academic years in certain specific and exceptional circumstances. An agreed change in fee status will only take effect from next academic year and will not be backdated. These exceptional circumstances include (but are not limited to) if you are granted refugee status in the UK. They do not include cases where students have not been able to demonstrate ordinary residence in the relevant area at the point this is requested.

It is your responsibility to ensure that you update the University regarding any change in your status in the UK that might affect your fee status, such as being granted Settled status through the EU Settlement Scheme.

Please refer to the UKCISA website for further information. Where students consider that our decision is incorrect, they are required to query this prior to accepting our offer of admission. If you believe that this assessment is incorrect you must notify us immediately via yourUAL Portal. You will need to tell us which of the Home categories you think you meet (using the UKCISA link above) and be prepared to evidence how you meet this category. You must not wait until enrolment as offers are not usually transferable.

# **Deferring your place**

Decisions on whether or not to allow a deferral will be at the discretion of the University and some courses do not permit deferral in any circumstance, so please check with us that you are able to defer before making the request.

If you would like to take up your offer but wish to defer your place to begin your studies in 2023/24 instead, you can make your deferral request before you have met the conditions of your offer, but you must first have made the required deposit towards your tuition fees.

- You must make your deferral request using your UAL Portal. We recommend making your deferral request
  as soon as you have made the decision to defer your place. Deferral requests are granted on a first-come,
  first-served basis.
- We will continue to accept deferral requests until all deferral places are filled, or until 5pm (UK time) 31
   August 2022 whichever is sooner. Requests to defer will not be accepted after this date and you will need
  to reapply for your course.
- Applicants may only defer once. If you deferred your place on your course in 2021/22 and do not take up your place in 2022/23, you will need to reapply if you wish to join your course at a later date.

# What happens next?

We hope you will decide to accept our offer and want to make sure you have all the information you need to do this, so please read this section carefully.

- The most important thing you need to do is tell us if you would like accept or decline our offer by 31 August 2022 if your course starts in September/October 2022 and 15 December 2022 if your course starts in January 2023. Please login to your UAL Portal to respond to this offer.
- Enrolment information will be sent to all applicants who accept their offer and meet their conditions by the
  deadline, so please make sure that we have your correct email address. You can check this or make any
  changes in your UAL Portal.

To officially enrol, you will need to bring your original official certificates, transcript of results or letters from relevant awarding bodies with you, as well as your offer letter, when you enrol in person at the start of your first academic year at UAL.

## Meeting and evidencing your conditions

You will need to provide evidence to us that you have met the conditions of your offer by 31 August 2022 if your course starts in September/October 2022 and 15 December 2022 if your course starts in January 2023.

For direct applicants, all results and other evidence of you meeting the conditions will need to be provided to us directly.

You can do this by uploading a copy of your original certificates, transcript of results or letter from the applicable awarding body. We can accept scanned or photographed copies, but unfortunately we cannot accept screenshots from online portals or pro forma letters where names have been inserted or written by hand. Any documents not in English must be accompanied by an official translation.

When you have received your results or certificates, upload these to your UAL Portal. If you don't do this, we won't be able to confirm your offer and we may be entitled to terminate the Student Contract.

- We will officially confirm that the conditions of your offer have been met through either UCAS or the UAL Portal, as relevant to your application. Until then, your offer will remain conditional.
- Don't lose your original certificates, transcripts or letter from the relevant awarding bodies: you may need to bring these with you when you enrol in person at the start of your first academic year at UAL.
- This is really important: if your offer is still marked as conditional at the beginning of the academic year, you
  will not be able to enrol at UAL.

The Student Contract gives us the right to terminate the Student Contract if you do not provide confirmation satisfactory to us that you have met the conditions of your offer in accordance with this email and within the specified time period.

## **English Language conditions**

If your offer includes an English language condition, it is important that you do not ignore this. It has been included for you because your application and circumstances indicate to UAL that you will need to demonstrate you meet the UAL English language requirements. It is important to note that if you will need a student visa in order to study at UAL, there are limited tests the University can accept. Please note, we do not accept International Baccalaureate English grades for applicants who need student visas.

### **Terms and Conditions**

If you accept this offer, you will have entered into a contract governed by our Enrolment Terms and Conditions (the "Terms") and other documents referred to in those terms (the "Student Contract"). The Student Contract sets out the basis on which UAL delivers educational services to students and provides details of your rights. If you do not wish to be bound by the Terms you should not accept this offer. You can read the full Terms here.

## Our right to withdraw this offer

We may withdraw this offer before you accept it, including, but not limited to, the following reasons:

- a. if it is reasonably necessary for us to do so as a result of changes in government regulations, such as amendments to the immigration rules; or
- b. if insufficient numbers of applicants to a course mean that it is not viable to run the course; or
- c. in certain other circumstances which are set out in our Admissions Policy (for example if you are convicted of a criminal offence or otherwise found guilty of a disciplinary offence after we have made an offer but prior to your enrolment).

## Your right of cancellation

Even if you accept this offer and enter into a legally binding Student Contract, you can change your mind and cancel your Student Contract from the time you accept this offer until 14 days after the start date of your course at UAL.

If you cancel your Student Contract within 14 days of accepting this offer or paying your deposit (whichever is the later), you will receive a full refund of any tuition fees you have paid, including any deposit paid. If you cancel more than 14 days after that date we will retain any deposit paid, together with an amount to cover our reasonable losses and costs because of the cancellation. For further details on your rights of cancellation and UAL's refunds policy please see the Terms and Conditions and the Fees Policy.

If you want to terminate your Student Contract after the course start date, please refer to your Student Contract and the Fees Policy for details about what refund rights might be applied.

## Important information for applicants requiring a Student route visa

You will need to demonstrate in accordance with the University's relevant procedure, either before or at the point of enrolment, that you have a valid immigration status to undertake your Course. Please refer to the Student Contract for further details.

#### **Course Transfers**

Your visa will be issued for a specific course. Once you have travelled to the UK on that visa, it will not normally be possible for you to transfer to another course. Any agreement to transfer will be at the absolute discretion of the University and will be affected by current UK immigration policy.

#### **Future Courses**

The UK Home Office has strict rules on the length of time you may spend studying in the UK under the Student route (previously Tier 4).

If you study more than one course under the Student route, the later course(s) must meet the Home Office rules on academic progression, which relate both to the level of course and the area of study.

If you undertake this course, you will only be able to study a further course under the Student route if the new course can be completed within the Student route time limit, and meets the academic progression requirements in operation at that time.
